

LICENSE AGREEMENT

Evaluation Images

THIS IS A LEGAL AGREEMENT BETWEEN YOU ("LICENSEE") AND JOHN TOBIN, ("LICENSOR"). LICENSEE'S USE OF THE DIGITAL IMAGES AS DEFINED BELOW CONSTITUTES YOUR AGREEMENT TO BE BOUND BY THE TERMS OF THIS LICENSE AGREEMENT.

GRANT OF LICENSE

WARRANTY

The sole and exclusive remedy for a breach of the foregoing warranty is the replacement of the Evaluation Images at Licensor's option. Licensor makes no other warranty, express or implied, including, without limitation, any implied warranties of merchantability or fitness for a particular purpose. Some states do not permit the exclusion of implied warranties, and you may have other rights, which may vary from state to state. Neither Licensor nor their Licensors shall be liable to you or any other person or entity for any general, special, direct, indirect, consequential, incidental, or other damages arising out of this license or otherwise.

All rights to the Evaluation Images are owned by Licensor and are protected by United States copyright laws, international treaty provisions and other applicable laws. Licensor retains all rights not expressly granted by this agreement.
